IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball at Paintball Atlanta, Thomcaro Outdoors LLC, I acknowledge and agree that:

1. The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize the risk, the risk of serious injury does exist.
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability below, and assume full responsibility for my participation: and,
3. I understand that the activities of paintball are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest officials as soon as practical: and,

I, for myself and on behalf of all my heirs, assigns personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS PAINTBALL ATLANTA, THOMCARO OUTDOORS LLC, the owners and lessors of premises used to conduct the paintball activities, their officers, officials agents, and / or employees ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and r wanton misconduct.
